

## INTERNSHIP POSITION INFORMATION : UNHCR, Dakar, Senegal (2 positions)

<b>Title:</b>	University of Toronto International Human Rights Program Legal Fellow

<b>Position Description:</b>	<p><b>Project Description:</b></p> <p>This fellowship program will provide recent alumni of the University of Toronto Faculty of Law with the opportunity to support the vital work of the UN Refugee Agency to help ensure the protection of refugees, stateless individuals, and internally displaced persons. Fellows will be stationed at UNCHR offices and will provide legal assistance that will have a direct impact on service delivery to stateless and refugee women, children, and men. Fellows will reinforce the technical capacity of UNHCR offices by providing legal research and support. During their tenure, fellows will have the opportunity to provide direct assistance to refugees and stateless individuals. In particular, they will have an opportunity to impact the lives of woman and girls, who make up half the refugee population and face heightened risks due to discrimination and gender-based violence. Fellows will also work directly with children, who comprise nearly half of the refugee population today and are in particular need of legal assistance, given their increased risk of abuse, exploitation, trafficking and forced military recruitment. This initiative will provide recent alumni of the University of Toronto Faculty of Law with international experience, skills, and knowledge to prepare them for future employment in the fields of international human rights law, public international law, immigration and refugee law, and a myriad of other sectors, both in Canada and abroad.</p> <p><b>Position Description:</b></p> <p>Two fellows will be placed in the UNHCR Dakar Regional Office in Senegal for approximately six months. There are approximately 13,700 displaced peoples living in Senegal that receive UNHCR support, most of whom are Mauritanian. Through this initiative, the fellow will provide essential legal capacity to UNHCR in Senegal, and will contribute to UNHCR's primary objectives to provide first-line care to those in need, to help the government maintain a favourable protection environment for refugees and asylum-seekers and to engage the government in ensuring the local integration of refugees. The fellow will also help to facilitate voluntary repatriation and to use resettlement strategically as a protection tool.</p> <p>The fellows will provide support to the Regional Statelessness officer in the form of the following activities:</p> <p><i>Preparation for regional statelessness conference</i></p>



- Co-ordination with country ministerial and NGO teams on gathering country specific inputs for conference
- Assisting development of declaration in statelessness taking into account the input of key actors
- Assisting in creating media messages and working on public information
- Co-ordination with other UN actors in the statelessness working group on thematic issues
- Providing administrative support on conference preparation and follow-up

*Research*

- Assistance in the preparation of a study on stateless children in Senegal
- Contribution to developing methodologies for identification of stateless persons in the region.
- Gather field information on specific countries of concern
- Gather statistical data on statelessness risk factors in specific countries of concern
- Conduct interviews with persons at risk of becoming stateless, as and when needed, in Senegal

*Development of legal guidance*

- Provide targeted legal advice for specific countries on statelessness and nationality related issues. Particularly in countries undergoing legal reform
- Updating internal legal tools on statelessness

Fellows will participate in a comprehensive pre-departure training program and will also receive career counselling and reintegration assistance upon completion of the program. The IHRP will fund all costs associated with training, transportation, travel medical insurance, and vaccinations, and fellows will be provided with approximately \$11,000 to assist with the costs of living during their fellowship.

**Qualifications:**

The following eligibility requirements must be met by all candidates:

- the candidate must have obtained a J.D. degree from The



	<p>University of Toronto Faculty of Law prior to the fellowship,</p> <ul style="list-style-type: none"><li>• the candidate must not be more than 30 years of age,</li><li>• candidates must be Canadian citizens or permanent residents,</li><li>• candidates must be legally entitled to work in Canada,</li><li>• candidates cannot have participated in DFATD's IYIP initiative,</li><li>• the candidate must be available to be posted overseas for six months, commencing in September 2016,</li><li>• previous course or equivalent experience in refugee law, and</li><li>• fluency in French is required for these posts.</li></ul> <p>Individuals interested in applying for a fellowships commencing in September 2016 are asked to send the following documents to the IHRP no later than April 15, 2016:</p> <ul style="list-style-type: none"><li>• a cover letter</li><li>• c.v.</li><li>• the names and contact information for three references</li><li>• all post-secondary transcripts</li><li>• a short essay explaining the specific needs or challenges that must be addressed in the field of international migration and refugee law (no more than 500 words).</li></ul> <p>Please note that while candidates are welcome to express interest in being posted to a particular office in their cover letter, all applicants are required to apply to the program generally, and the geographic assignment of fellows will be made after candidates have been selected for participation in the program. Today, a staff of more than 9,300 people in 123 countries continues to help and protect millions of refugees, returnees, internally displaced and stateless people.
